Update on 16 <sup>th</sup> and Maku`u burial cave	<p>Information that was shared with the committee by Keoni Alvarez at the last meeting and reported in the minutes was discussed.</p> <p>Danee McFarr contacted Larry Torres, HPPOA manager, to correct and clarify information in documents regarding construction activity on the mailbox site in October 2023 and July 2024. (Larry Torres was identified as Larry Kawaauhau in the October memo from the state archaeologist.) In his email reply, he stated that on October 16, 2023 (when the cave almost 200 feet away from the site was reported) "When asked if the construction was going to be coming any closer to this site, that is when I told them 'no.'" I replied to Larry, asking him why there was additional bulldozer activity (which created the new cave opening) in July of 2024 when the authorities were told nine months earlier that work was complete? Larry replied that he spoke to Lanell and that "Further clarification would need to be done in-person at the site."</p> <p>The committee agreed that clarification is needed from Larry. <p><b>GUEST PRESENTATIONS</b></p> <p>Keoni Alvarez, Burial Cave Steward: Update on 16<sup>th</sup> and Maku`u burial cave</p>	Keoni is recognized by the Hawai`i Island Burial Council as the steward of the 16th and Maku`u burial cave site. The Council recommended that the buffer zone be increased from ten feet to 20 feet. Keoni will propose to the HPPOA board at the next executive session to extend the front section buffer to 20 feet. The final treatment plan has not yet been completed and presented to the Burial Council.	For information.

Keoni Alvarez (cont'd)	Keoni presented a timeline regarding the discovery of the burial cave and showed the burial site treatment plan. On October 9 the cave was surveyed; the surveyor will do mapping and show the buffer zones at a later date.	
Palikapu Dedman, Pele Defense Fund	<p>Keoni introduced his mentor Palikapu Dedman, cofounder in 1985 of the Pele Defense Fund, which is dedicated to defending traditional Hawaiian rights and customs.</p> <p>Uncle Pali shared the history and culture of burial caves and his decades-long activism to protect them. He has been successful in organizing actions and stopping development in areas with iwi kupuna, as well as aiding in enforcing the law requiring that iwi kupuna be left in place, or reburied when discovered later, as occurred with holdings in the Bishop Museum.</p> <p>He asked the committee to consider taking part in actions, such as meeting with legislators, to encourage them to enact resolutions and submit bills for laws to further protect iwi kupuna. There is a need for an independent burial council or commission for Hawai'i island made up of Hawaiians and a law requiring realtors to have an archaeological inspection of any property offered for sale.</p>	For information.
